CALL TO ORDER: Sean Coletti called the meeting to order at 3:43

DISCUSSION ITEMS

FY 2021 TIP Modification #20

Darrell went over the changes to the TIP, the modification includes reversals of previous modifications, project delays and additions to projects. See attached

CONSENT ITEMS

Jim Francis made the motion to approve the minutes of the October 13, 2021, TAC/PB Joint Meeting, with the amendment to add the specific information for the changes (see attached) on the GIFT Memorandum of Agreement. This was seconded by Larry Gilmore. The vote was unanimous.

ACTION ITEMS

Connecting Our Community (COC) Map

DaNiel showed the updates to the COC map. TAC suggested the map should be updated more often than every 5 years. There have been several updates to the map since it was originally adopted in 2015. TAC made the recommendation to approve the map. **Rebecca Casper**

recommended to adopt the COC map with the updates, modifications and recommendations from TAC as follows.

- Remove the red bridge that's shown over the river in downtown.
- Change the color of the path at John's Hole Bridge to the West.
- Extend pathway to West 33rd South over to line up with Sunnyside.
- Show the Idaho Canal improvements to Lovejoy.
- Show improvements along Elva by the golf course.
- Extend pathway from 17th South to 35th West.

John Walker seconded the motion. The vote was unanimous.

FY 2021 Transportation Improvement Program (TIP) Amendment #6

Darrell discussed Amendment #6 for the crossing at Anderson and Holmes rail updates. This project was not previously in the TIP. Amendment was still out for public comment. **Motion to approve made by Jim Francis and was seconded by Rebecca Casper**. The vote was unanimous.

DISCUSSION ITEMS

Project Schedules for FY 2023 TIP

Proposed locally sponsored projects and application due dates were discussed, see attached.

Draft of the FY 2023 Surface Transportation Block Grand-Urban (STBG-U) Application

Darrell discussed the requirements and criteria for the STBG-U grant applications. Availability of funds and caps as well as deadlines for projects were presented. There will be 4 separate applications for the different project types. Each will include a check list of attachments needed and a scoring sheet. The committee liked the changes to the scoring points that they had previously suggested.

Long Range Transportation Plan (LRTP) Steering Committee Update

At the meeting present conditions and needs were discussed along with public comments related to needs. Additional comments were gathered from committee members. Among the comments gathered is the need for public transportation.

STBG-U Funding Apportionments Meeting Update

MPO's requested use of the annually updated federal STBG urban area apportionment with the rural area apportionments increase to equal the urban are apportionments. LHTAC and others requested a 15% split between rural and urban areas. Discussion on STBG-U Fundings Apportionments will continue.

Summary of Proposed Locally Sponsored Project Schedules

Bridge Program

Local Bridge and Off-System Bridge Program applications are accepted every other year for a two year programming period. This would have been a year that applications were accepted however federal-aid funds are fully programmed.

Local Highway Safety Improvement Program (FY 2024)

Electronic application submittal by sponsor to LHTAC by January 19, 2022 by 4:00 pm. Please include BMPO in CC.

STBG-Rural (LHTAC) — Projects within BMPA boundaries

STBG-Rural applications are accepted every other year for a two year programming period. The previous year (FY20-21) would have been a year that applications were accepted however, due to increased project costs, the program was over-programmed, and applications were not being taken. FY21-22 is an off year.

STBG-Urban (Preliminary Development) - Roadway (System), Pavement, Safety and Study

Submit Surface Transportation Block Grant Program — Urban (STBG-U) project application to BMPO electronically by January 26, 2022, by 4:00 pm. Note: include attachments ITD 1150 and 2435 forms.

- Applications available on BMPO's website on <u>December 1, 2021.</u>
- Training session (if necessary) with potential applicants will be held on an as needed basis.
- No later than February 1, 2022 BMPO staff will notify applicant if the application is accepted, rejected and/or needs corrections. If an application needs to be corrected, the revised application will be due to BMPO by February 7, 2022 at 4:00 pm.
- Sponsors will present project information to TAC on February 9, 2022.
- TAC members will score applications and submit to BMPO by 4:30 pm on March 2, 2021.
- BMPO staff will present summary of scoring at the March 9th TAC and March 16th BMPO Policy Board meetings. Projects will be prioritized by considering the rating, available funding and other values.

Transportation Alternatives Program (TAP)

TAP electronic application submittal deadline to LHTAC is January 20, 2022 by 4:00 p.m. Application should be in a single PDF file. Please include BMPO in CC.

Summary of Proposed Locally Sponsored Project Schedules

FTA 5307 and 5339

Written request with project descriptions and cost estimates are dependent on decisions made regarding public transportation services. Once resolved and if necessary, BMPO will work with the grant recipient/project sponsor to program federal transit funds.

FTA 5310

No call for applications is scheduled as funds are related to and support public transportation for enhanced mobility of seniors and individuals with disabilities.

Other Federal-Aid Programs

Local entities may be eligible to sponsor projects via other federal-aid transportation funding programs. However, funds are generally tied to stringent criteria or are nation-wide competitive bid. Around March, BMPO staff typically provides an annual update of the federal-aid programs. If a local entity is interested in sponsoring a project from another federal-aid program (NHPP, etc.), representatives from District 6, the local entity and BMPO should meet to discuss programming feasibility. District 6 will provide available information regarding potential state sponsored projects located within the BMPO boundaries at the February and/or March TAC/Policy Board meetings.

Children Pedestrian Safety Program Application Deadline: Complete application electronically by December 16, 2021 at 4:00 p.m. to LHTAC. Limit one application per City, County or Highway District.
