Key Numbers 23702 and 23703 move to CE/CN (with 25 percent increases) from PD in 2028. Jim Freeman seconded the motion. #### **STBG-U New Project Priorities**

Darrell West went over the scoring of the new STBG-U Projects.

- -Six projects at a total cost of about \$15 million
  - Four projects are roadway reconstruction and expansion.
  - Two projects focused on pavement conditions.

15<sup>th</sup> East Roadway Expansion and Improvements – Sunny Pine to Elk Creek - \$4,493,000 Ammon Road/1<sup>st</sup> Street Traffic Signal and Intersection Improvements - \$1,300,000 E Street Roadway Expansion and Improvements – Memorial to Yellowstone - \$3,267,000 Holmes Ave Roadway Expansion and Improvements – Taylorview to Sunnyside - \$3,700,000 26<sup>th</sup> West Pavement Reconstruction/Widening – 17<sup>th</sup> N to 33<sup>rd</sup> N - \$1,000,000 26<sup>th</sup> West Pavement Reconstruction/Widening – 33<sup>rd</sup> N to 49<sup>th</sup> N - \$1,000,000

- -Two local communities submitted the 6 projects
  - City of Idaho Falls 3 projects
  - Bonneville County 3 projects
- -Eleven TAC members participated in scoring the projects

TAC recommended to follow the score ranking of the New STBG-U Projects to the Policy Board. The Policy Board discussed the TAC Ranking of the New STBG-U Projects. The Policy Board reordered the New STBG-U Project Priorities from the scoring order. Jim Freeman made the motion to prioritize the projects in the following order, Ammon Road Signal, Holmes - Taylorview-Sunnyside, E Street – Memorial to Yellowstone, 15<sup>th</sup> East – Sunny Pine to Elk Creek, 26<sup>th</sup> West Widening 17<sup>th</sup> N to 33<sup>rd</sup> N, 26<sup>th</sup> West Widening 33<sup>rd</sup> N to 49<sup>th</sup> N. Rebecca Casper seconded the motion. A roll call vote was as follows: Burtenshaw, yes; Casper, yes; Freeman, yes; Gilmore, yes; Minzghor, yes; VanderMeer, yes; Ziel-Dingman, yes. The motion passed.

#### **DISCUSSION ITEMS**

#### **High Capacity Roadway Study Update**

Darrell West said the HCRS Steering Committee met to discuss if the HCRS Methods and Assumptions appropriately captured everything from the previous meeting, the public involvement discussion with Policy Board and TAC officers, and submitted comments primarily focused on added projects.

After discussing changes to the project list for anticipated construction years and the inclusion of using the ITD Public Outreach Plan (POP) the Committee accepted the Memorandum.

#### **Urban and Planning Boundaries**

Darrell West discussed smoothing the urban planning boundaries.

Primary reasons to smooth the urban boundary

- Align with existing planning boundaries
- Incorporate local knowledge of urban landscape/characteristics
- Address irregularities in boundary shape
- Maintain consistency with highway functional classifications

Other reasons to smooth the urban boundary

- Include the entire municipality
- Include significant traffic generators such as airports, industrial areas, etc.

The smoothing of the boundary increases the size of the urban area and therefore increases the number of roadway segments that are eligible to receive STBG-Urban funds. However, those areas added to the urban area are no longer eligible to receive STBG-Rural funding.

The smoothing of the boundary does not increase the population that is used to distribute metropolitan planning funds. The urban population is also used to determine the allocation of various federal-aid funding programs.

Ucon is no longer within the urban area but will remain in the Bonneville Metropolitan Planning Area (BMPA) if the boundary is unchanged.

All projects regardless of federal transportation program funding, in the urban area and metropolitan planning area, need to be programmed in the Transportation Improvement Program (TIP).
