
## MINUTES - Policy Board Meeting October 18, 2023

## FY 2023 TIP Annual Listing

Darrell West went over the FY2023 TIP Annual Listing. He gave an example of how to compare the annual listing with the TIP. A majority of project obligations equaled the amount programmed in the FY 2023 TIP. A handful of the project obligations were slightly higher or lower than the amount programmed. A few project obligations were different from programmed funds due to adjustments. The FY2023 TIP Annual Listing has been added to the FY2023 TIP on the BMPO website.

# **FY 2025 TIP Project and Application Schedule**

Darrell West went over dates the FY2025 TIP Applications are due and some adjustments made to the application process.

# **Strategic Initiatives Grant Program Project Status**

Darrell West updated Policy Board Members with the lates information on the Strategic Initiatives Grant Program project status. ITD presented a list to the MPO Directors three weeks ago that included 2 of our projects. The Pancheri Bridge project and the Iona Road project. The Ammon Road project was not on the list. However, the list was not complete as it only included the allocation of \$31 million and thus required that a remaining \$19 million be allocated to projects.

Today, ITD released a "recommended" list for Category 1 and 2 projects, that will be presented as grant recipient award list for IT Board concurrence in December.

# **High-Capacity Roadway Study Update**

Last night from 5 to 7 pm at CEI there was the first High-Capacity Roadway Study (HCRS) public open house. The open house focused on addressing future traffic with new and enhanced corridors.

There was a good turn out and the public provided a lot of comments. BMPO staff and consultants will be reviewing and considering all comments. Comments that may not specifically be applicable to this study will be forwarded to those that can address them, further they can be used when identifying conditions and needs for the Long-Range Transportation Plan.

The public also, noted locations on maps where there are congestion, safety, access, neighborhood cutthrough, bike, pedestrian and transit problems or needs.

The public can continue to review the open house slides and provide comments on BMPO's website.
