A contract will be developed and reviewed by the appropriate parties. It's expected that the contract with the accompanying scope, hours, and costs will be on the November TAC and Policy Board agendas for approval.

Jason Minzghor introduced Wade Allen, ITD Engineer and Jeff Sneddon, ITD District 6 Planner who is replacing Brad Richards on TAC to Policy Board and TAC.

I-15/US 20 Environmental Impact Study (EIS) Update

Darrell discussed the updates on the EIS for the I-15/US 20 Connector Project.

A public meeting was held yesterday that provided the public with the opportunity to review the outcomes of the PEL study and give comments as the project moves into the EIS phase.
